



## Scan Tags and Log Observations

To execute policies, personnel must physically scan each location tag with the LCS mobile device and log observations. Officers and supervisors receive phone, text, and email alerts if any check is in danger of being missed.

All data and observations are automatically stored on the cloud and are accessible from an administrator dashboard where you can view activity in real time and generate reports.

## Customizable Alarm Settings

## Push Notifications

Officers conducting watches receive visual push notifications on their device informing them of anything behind schedule.



## Graduated Alarms

Devices sound an audible alert that gradually increases in intensity until the check is made.



## Emergency Alerts to Supervisors

If the observation still has not been made, the system will call, text, and email supervisors and management to let them know immediately.



## Live Count

## Real-Time Monitoring

When officers scan inmate wristbands, the device will display the inmate's photo to confirm identity.



## Require Photos and Videos

Enable photo and video capture for visual confirmation of inmate safety.




## Customize Data Entry


